DESCRIPTION (1)

"We Cross Borders" Project

The main objective of the project is to contribute to the development of cross-border cooperation between the two countries

The aim of the project is the creation of new infrastructure at the Greek (Evzoni) -North Macedonia border stations (Bogorodica).

The specific objectives of the project are:

- Improving the level of customs services at the Evzoni and Bogorodica border stations
- Introducing automated systems for the service of transit vehicles and travelers and the support of Customs Services
- Strengthening bilateral trade
- Increasing cross-border mobility
- Improving the safety of tourists
- Preventing and combating the smuggling of drugs, weapons and fuel
- Addressing illegal immigration
- More effective supervision and protection of the European Union's external borders

- Improve the working conditions for the Customs' personnel in both countries.
 Minimize the required time for processing people and goods at the Customs offices.
- Enhance the sense of safety for tourists.
- ▶ Eliminate traffic congestion in the Border Crossing Points of Evzoni and Bogorodica.


